## → What is the Summer School of Civil Law ?

International legal meeting for Civil law and legal culture, this event brings together every year many students and legal practitioners from all around the world. In 2021, the Summer School is back in a 100% digital format, from June 29th to July 29th, considering travel restrictions due to the health crisis. Our ambition remains the same: to provide all participants with a body of knowledge on civil law, its evolution, and its influence on legal and economic models around the world.

The richness of our Summer School lies in the quality of the education which comes from the prestigious and internationally renowned University of Paris 2 Panthéon-Assas as well as in the diversity of the legal cultures represented which leads to privileged moments of meeting and debate.

## → Description of the program

The program comprises four mandatory courses :

### Expected audience

**Any person**  
(law students, legal practitioners, etc.) who have already graduated from a three-year of legal studies.

### 3 linguistic streams

**French, English, and Spanish**  
(A good level of language skills will be required in each of the courses offered).

### Registration fees

**619 euros**  
(Scholarships can be exceptionally granted on justified request).

→ **Course schedule from June 29 to July 29, 2021**

- **For the French-speaking stream**, classes will be held from Monday to Friday from 18:00 to 20:00 (Paris time).
- **For the English-speaking and Spanish-speaking streams**, classes will be held from Monday to Friday from 17:00 to 19:00 (Paris time).

*Exceptional changes may occur.*

**If successful at the final examination, participants will be awarded a Training Certificate in Civil Law delivered by the University Panthéon-Assas (Paris II).**

**The Foundation for Civil Law will also organize online meetings with the main French legal actors**, including lawyers, notaries, court commissioners, commercial court clerks, court-appointed receivers and company lawyers.

At the end of the Summer University, participants can have the chance to join the Association of Friends for Civil Law (A2DC) and becoming part of a wide-ranging network of legal actors around the world.
